Note #2 A candidate does not seek election to any specific vacancy. The candidates who receive the most votes (plurality) shall be elected.

Note #3 Completed petitions shall be returned to the Clerk of the District, Business Office of the Hoosic Valley Central School District, 2 Pleasant Avenue, Schaghticoke, New York, no later than **3:00 p.m. on Monday, April 17, 2023**

Note #4 On **Tuesday, May 16, 2023**, the qualified voters of the Hoosic Valley Central School District shall elect one (1) member to a four (4) year term commencing July 1, 2023 and expiring on June 30, 2027.
