2022-23 Budget Development Governor's Budget Proposal February 3, 2022

Governor's Budget Summary

- Overall the NYS Budget calls for a \$2.1 Billion increase for NYS's public schools.
 - \$1.6 billion increase in foundation aid
 - \$466 million increase in all other school aid
- The executive budget is generally the starting point for budget negotiations between the governor and the legislative houses
 - To be followed by counter-proposals from both houses of legislature before enacting the final budget.
 - The deadline for the budget to pass and be considered on time is April 1, 2022.
- Traditionally, the amounts released later in the Spring are higher than the Governor's budget.

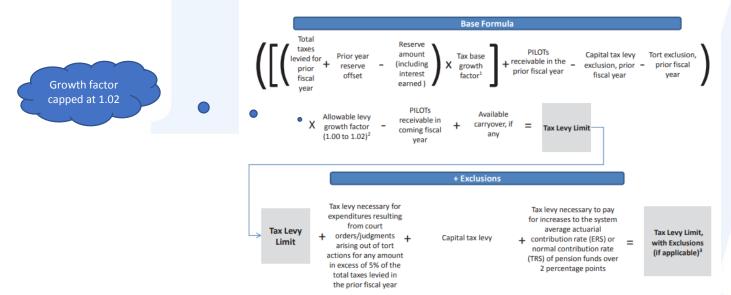

2022-23 Tax Levy Limit

- New York State's Property Tax Cap the tax cap limits the total levy set by school districts.
- 2022-23 Maximum Allowable Tax Levy, including exclusions is 8,832,211 or 4.084%. (estimate)

- Develop a budget that keeps taxes at or below the tax levy limit.
- Establish a budget that manages our general fund resources alongside unprecedented federal aid to strategically plan for the future.
- Provide the necessary resources to ensure our school meets the immediate and long-term needs of students and staff given the impacts of the pandemic.
